

FACTS WHAT DOES ANGEL OAK MORTGAGE SOLUTIONS LLC COMPANY DO WITH YOUR PERSONAL INFORMATION?

Why? Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What? The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- **Social Security number** and **Credit scores**
- **Checking account information** and **Transaction or loss history**
- **Income** and **Assets**

How? All financial companies need to share **Customers** personal information to run their everyday business. In the section below, we list the reasons financial companies can share their **Customers** personal information; the reasons **Angel Oak Mortgage Solutions LLC** chooses to share; and whether you can limit this sharing.

How does Angel Oak Mortgage Solutions LLC collect my personal information?	We collect your personal information, for example, when you <ul style="list-style-type: none"> • Apply for a loan or • Give us your income information or • Provide employment information or • Give us your employment history or • Give us your contact information We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.
Why can't I limit all sharing?	Federal law gives you the right to limit only <ul style="list-style-type: none"> • Sharing for affiliates' everyday business purposes – information about your creditworthiness • Affiliates from using your information to market to you • Sharing for nonaffiliates to market to you • State laws and individual companies may give you additional rights to limit sharing.
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account

Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> • Angel Oak Home Loans LLC • Angel Oak Lending, LLC • Angel Oak Capital Advisors LLC
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> • <i>Angel Oak Mortgage Solutions LLC does not share with non-affiliates so they can market to you.</i>
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you <ul style="list-style-type: none"> • <i>Angel Oak Mortgage Solutions LLC does not jointly market.</i>
